- Dead grass will need to be reseeded West will request cost quote from Pacific Roots
- Tree pruning is being addressed
- Weed abatement treatment has been placed on the weeds and continues to be addressed
- West will speak with Pacific Roots about leaves and other tree material in the streets
- West will speak with Pacific Roots about grass clippings that need to be blown off of sidewalks and homeowner properties
- Irrigation Status (Improvements RFQ)
 - No responses to the RFQ at this time
 - West will work with Pacific Roots to get a quote for the work that needs to be completed in small sections each month rather than one big contract
- Tree Removal RFQ Good Bloke Quote
 - Review of quote
 - Chambers will follow-up and send Simpson the list of replacement tree types recommended by City of Central Point. Simpson will work with Good Bloke to update the quote with choices from the recommended tree list
 - Simpson will follow up with Good Bloke on permit requirements from City of Central Point for tree replacement and removal
 - Simpson and West will review current budget to see if a second round of tree removal can happen this winter
